COMPLIANCE WITH UNITED STATES EXPORT REGULATIONS

End-User/End-Use Statement Form:

It is the policy of GAS Global Aerotech Support Corp. to verify the end use and end user in the sale, lease and/or distribution of all products, services or documentation by GAS Global Aerotech Support Corp. to ensure compliance with applicable U.S. export control laws and regulations. Because the products, services or documentation you are purchasing, leasing or receiving may be exported and used outside of the United States, please confirm the following:

1. I (We) will not export or re-export any product, service, or documentation subject to the U.S. Export Administration Regulations ("EAR") (15 CFR 730-799) purchased, leased and/or distributed from GAS Global Aerotech Support Corp. to any United States prohibited or restricted countries unless otherwise authorized by the United States Government. The Regulations expressly prohibit the sale or provision of GAS Global Aerotech Support Corp. products to countries embargoed by the U.S., to any unauthorized party for use in activities related to weapons of mass destruction, or to parties expressly prohibited by the U.S. Government from receiving products of U.S. origin. Note: Please pay close attention to 15 CFR Parts 736 (General Prohibitions), 738 (CCL & Country Chart), 742 (CCL Controls), 744 (End-User/End-Use based policy), 746 (Embargoes & Special Controls), 760 (Restrictive Trade Practices or Boycotts), and 774 (CCL).

I (We) understand that the Regulations prohibit the sale or provision of GAS Global Aerotech Support Corp. products, services, or documentation to countries listed in Country Group E of Part 740, Supplement 1 of the EAR and also prohibit the sale of said products for use on aircraft owned, chartered, or controlled by entities located in said countries, regardless of the aircraft's location, without the express, prior, written authorization of the U.S. Dept. of Commerce and/or the U.S. Dept. of the Treasury.
3. I (We) will not knowingly sell or otherwise provide for activities expressly prohibited by the Regulations 15 CFR 744.21 for use or benefit of the military of the People's Republic of China
4. I (We) will not export or re-export any product, service, or documentation subject to the International Traffic and Arms Regulations ("ITAR") (22 CFR Chapter I, Subchapter M, Parts 120-130) purchased, leased and/or distributed from GAS Global Aerotech Support Corp to any prohibited or restricted (embargoed) countries unless otherwise authorized by the United States Government.
5. I (We) acknowledge that U.S. law prohibits the sale, transfer, export or re-export or other participation in any export transaction involving product, service, or documentation purchased, leased and/or distributed from GAS Global Aerotech Support Corp. with individuals or companies listed in the U.S. Commerce Department's 'Denied Persons', 'Unverified', or 'Entities' Lists, or the U.S. Treasury Department's List of Specially Designated Nationals, or the U.S. Department of State's Debarred Parties List.
